## SALES CONTRACT/WARRANTY

Sarken Kennels Policies: (as of 1/1/07) (may be superseded by successive Policy revision)

**1. Puppy guarantee** – Any reference to “puppy” refers to an Irish Wolfhound purebred AKC registered, micro chipped, puppy. Upon possession of the puppy according to the date on our receipt, we give a “warranty” based on these conditions:

- A.** The puppy must be taken to a licensed veterinarian and examined within 72 hours of the transfer of the puppy.
- B.** If the puppy is found to be fatally congenitally deformed, or found to be fatally infected with disease, the veterinarian will put the puppy down and send us an original letter on his office letterhead including the date of examination, directly to us, stating his findings and that the puppy was euthanized.
- C.** If the puppy is found to have a non-fatal but unsatisfactory health problem within the first year of the puppy’s age which would make the puppy unfit for future breeding, the puppy may be shipped back to us, at the owners expense, along with registration papers, receipts, and vet statements for a replacement puppy of the same type, quality and gender from the next available litter not having previous obligations.
- D.** If the puppy is shipped, insurance from the airline carrier is mandatory and will be in force and effective until the puppy has landed and is in the hands of the new owner listed above.

These are the only conditions warranted by Sarken Kennels and any conditions other than these are not warranted. If the examination is not performed within 72 hours of possession and the letter not sent directly from the veterinarian’s office, or not including the date of examination, the warranty is null and void and will not be honored by Sarken Kennels. Also, if the puppy is shipped by commercial air transport; the date of shipment initiates the 72-hour period permitted for licensed veterinarian examination.

**2. Fulfillment of Warranty** - Upon receipt of the letter from the licensed veterinarian, we will review his findings and request the return of the original registration and any copies of our receipts of payments of the deceased puppy for our records. We will then allow a choice to the client of the same type, quality, and gender out of the next available litter produced. This policy is not intended to cause alarm to the potential client, as we have not had any occurrences of events leading to or causing a fatality of the puppy to date.

**3. Deposits** - A non-refundable \$750.00 deposit is required to hold the puppy for a client until the client collects the puppy or it is shipped via commercial airline. Full and final payment is due by any of the methods of payment listed above, when the puppy reaches six weeks of age, or, in cash upon collection of the puppy. Puppies can generally leave Sarken Kennels at six weeks of age, if collected, or can be shipped at, or after, eight weeks of age. The deposit is non-refundable and non-transferable to another puppy. This policy is to protect and ensure that we may conduct business in a fair manner with other prospective clients and that we are not impaired by loss of potential sales to another client due to a client’s change of mind.

**4. Payments** - Payments of any kind, deposits or otherwise, are accepted in the form of cashiers check, U.S. Postal money order, personal check (if received 10 days before puppy is collected or shipped), cash, or credit card via PayPal.

**5. Receipts and Registration** - Any time a payment is made, a confirmation will be issued, generally via email. All of Sarken Kennels puppies are AKC registered within 10 days of birth and AKC paperwork is generally available before the puppies reach six weeks of age. However, due to circumstances beyond our control, occasionally AKC registration papers are not returned in a timely manner. In this case the paperwork will be mailed, via US Priority 2-3 day mail, as soon as we receive them.

If **AT ANY TIME** during the life of the dog the current owner cannot keep him then, by signing below, you are agreeing to return the dog to Sarken Kennels who may keep the dog or find an alternative suitable home.
